### SECTION 4: First aid measures

#### 4.1. Description of first aid measures

### SECTION 7: Handling and storage

#### 7.1. Precautions for safe handling

**Usage precautions** Eliminate all sources of ignition. Use only in well-ventilated areas. For professional users only. Wear protective clothing as described in Section 8 of this safety data sheet. Earth container and transfer equipment to eliminate sparks from static electricity. For the greatest protection, clothing should include anti-static overalls, boots and gloves. Use only non-sparking tools. Keep away from heat, sparks and open flame. Avoid inhalation of vapours/spray and contact with skin and eyes. Inhalation of dust during cutting, grinding or sanding operations involving this product may cause irritation of the respiratory tract.

#### Appropriate engineering controls

As this product contains ingredients with exposure limits, process enclosures, local exhaust ventilation or other engineering controls should be used to keep worker exposure below any statutory or recommended limits, if use generates dust, fumes, gas, vapour or mist. Use explosion-proof ventilating equipment.

#### Eye/face protection

Eyewear complying with an approved standard should be worn if a risk assessment indicates eye contact is possible. Personal protective equipment for eye and face protection should comply with European Standard EN166. Chemical splash goggles or face shield. If inhalation hazards exist, a full-face respirator may be required instead.
