#### SECTION 4: First aid measures

### 4.1. Description of first aid measures

<b>General information</b>	If in doubt, get medical attention promptly. Never give anything by mouth to an unconscious person.
<b>Inhalation</b>	Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. If breathing stops, provide artificial respiration. #### Appropriate engineering controls

Provide adequate ventilation. As this product contains ingredients with exposure limits, process enclosures, local exhaust ventilation or other engineering controls should be used to keep worker exposure below any statutory or recommended limits, if use generates dust, fumes, gas, vapour or mist.

#### Eye/face protection
